## **FIREARM TRANSFER AGREEMENT \*\*PLEASE READ AND INITIAL\*\***

\_\_\_\_\_ **With House Bill 1240 progressing towards approval, I am aware that there may be potential issues with my transfer relating to the release of my firearm. I am aware that if House Bill 1240 is implemented, I as the transferee will be financially responsible to return the firearm to the seller.**

\_\_\_\_\_ If we do not receive this transfer form **prior** to your firearm arriving, the transfer fee will be \$75.

\_\_\_\_\_ Receiving and processing of the firearm may take up to two business days (Monday-Friday) after confirmation of delivery. Once processing is complete, a SafeFire employee will notify you via your contact information.

\_\_\_\_\_ I understand and acknowledge the law as it relates to the interstate transfer of firearms.  
**(Oregon residents MUST have firearms shipped to an Oregon dealer. We will not accept them.)**

\_\_\_\_\_ I understand and agree that items not claimed within 30 business days are subject to storage fees. Items unclaimed after 90 days will be surrendered to SafeFire LLC and sold. Denied transactions will still be charged a transfer fee. Any additional denials following the first will be charged a \$100 processing fee. Furthermore, a denied buyer has 30 days to arrange for a refund from the seller and pay return shipping.

\_\_\_\_\_ **I understand I must provide a copy of my receipt along with this form per Washington Department of Revenue.**

\_\_\_\_\_ I understand that I **cannot** transfer in a firearm with a magazine capacity larger than 10 rounds. If a transfer arrives after July 1st, 2022 with magazines over a 10 round capacity, I will not be given the magazines. I understand that refusing to take my **firearm without the magazines will result in a \$100 return to sender fee, not including shipping, which must be arranged with the sender. If sender refuses the return, I will need to complete a background check and take possession of the firearm upon approval, without the magazines.**
